**Vehicle information should be entered in accordance with information contained in *The Splendid Stutz*.**

- a. The "Make" or "Series" specifications start on page 373 of *The Splendid Stutz*
- b. The "Model" should be specific, e.g., 5-P Brougham, 7-P Sedan
- c. The "Body" is the body builder, e.g., LeBaron, Hale Kilburn; as indicated by an identification plate attached to the car. (Otherwise the body is stock) If it is a replica, please mark with an asterisk (\*) and indicate the original body.
- d. "V.I.N." (Vehicle Information Number) is used in some areas of the United States. Is is sometimes identical to the engine or chassis, but the number often has significance only in the bureaucratic sense. If your locale does not have a similar system, use a specific identification number relating to your vehicle such as Car No., FEDCO or chassis number.
